The Oncologist has finally published an editorial in conjunction with a second correction. The study has now been revalidated and will remain in the literature. Professor Michael Frass and his team are very happy about this success, which was made possible with ECH's help. Ten years of work and intensive correspondence with The Oncologist over the past two years have finally borne fruit. As Winston Churchill said: Never, never, never, never—in nothing, great or small, large or petty—never give in.

Prof Frass will now enter intensive legal discussions to fight against the defamation of his character, following the finding against him of fraud and misconduct by the Austrian Agency of Scientific Integrity.

# ENIPAR CALL TO UN FOR ACTION ON AMR

The European Network on Infection Prevention and Antimicrobial Resistance (ENIPAR) has issued a Call to Action to the UN High-Level General Assembly on Antimicrobial Resistance

As AMR stands out as one of the top 3 health threats in the EU, a new Call to Action with baseline recommendations urges decision makers to take timely action to ensure that 2030 targets are met. Successful implementation of high-impact, evidence-based interventions is key to strengthening the EU response to healthcare-associated infections and AMR prevention and control. The factors that make this possible work best in combination and include the following areas: governance and leadership; surveillance; community and workforce awareness; IPC instruments; and medical technologies and tools.

The Call to Action is supported by over 20 organisations, including ECH and HRI.

# SPINE CURVED BY TB STRAIGHTENS AFTER HOMEOPATHIC TREATMENT



Camilla and Jeremy Sher report from Tanzania:

A little girl was brought to us with a curved spine. She had contracted tuberculosis as a baby, very common with the Masai people as they drink raw unpasteurised milk direct from the cow. The TB had gone into her spine (spinal tuberculosis, or Pott's disease). As a result, she was unable to sit or crawl, let alone stand or walk. She was floppy and weak, with a constant cough and runny nose. One a half years of homeopathic treatment later her spine is normal and she can now walk!

She was initially prescribed Calcarea phosphorica 12c daily for a month, with moderately good results and an improvement in her general health. The prescription was then changed to Phosphorus 12c daily for a further month and repeated about three times over an 18-month period. It was wonderful to witness the transformation in this little girl.

#### **DATA REPOSITORY UPDATE**

Dr Marcus Zulian Teixeira is among the top 2% of scientists in the world and among the 249 most influential researchers at the University of São Paulo (USP), according to Stanford University's 2024 ranking.

Professor John PA Ioannidis, a researcher in the Departments of Medicine, Health Research and Policy, Biomedical Data Science and Statistics and of the Center for Meta-Research Innovation at Stanford University (Metrics), released the latest version of the database of the most cited researchers, the <u>Updated science-wide author databases of standardized citation indicators</u>. This is the seventh edition of the project, which aims to provide standardised metrics to assess the impact of researchers in various areas of knowledge and list the most influential scientists in the world.

# HOMEOPATHY – AT A TURNING POINT


#### Dr Dei writes:

Homeopathy is at a turning point, having failed to communicate a message that justifies its existence. This failure is due to the fact that many of its followers have adhered to a philosophy that did not consider such communication necessary—an approach that does not help one see far ahead. Additionally, others have not recognized their stagnation in a world made dynamic by the progress of scientific research and information dissemination. In short, the cause of crisis lies in the fact of having postulated an emerging character (i.e., the superiority of the whole over the sum of its parts) in the holistic view, without bothering sufficiently to define the properties of the parts.

Yet I remain optimistic, believing that the progress of humanity began in a place like the ancient Greek city of Miletus, where different worlds met, and was accomplished when people left the isolated fortress to engage in discussions in the agora (the city-centre gathering place of ancient Greece). I believe that both Miletus and the agora can be identified with the pages of this journal. I am not afraid to discuss my ideas; nor am I afraid, but rather delighted, at the prospect of having to change them.
